Snow Removal - It's inevitable! Snow will be falling in the next few months!!! Please note the following: The City of Alma would like to express its appreciation for its citizens who understand the importance of keeping their sidewalks free of snow and ice. According to City Ordinance 96.20, it shall be unlawful for the occupant of any lot(s) or the owner of any vacant lot(s) within the corporate limits to allow snow, sleet, mud, ice or other substance to accumulate or remain on said sidewalks.

Residential sidewalks shall be cleaned within 24 hours after the snow storm. All sidewalks within the business district shall be cleaned within 5 hours after the cessation of the storm, unless the storm or fall of snow shall have taken place during the night, in which case the sidewalk shall be cleaned before 9:00 a.m. the following day.

Take special care and use common courtesy when clearing your driveway. Ask for your neighbor's permission before you pile your snow on their **terrace (area between curb line and property line)** or yard. Rocks and other debris can collect on your driveway and by piling your snow on your neighbor's property you are depositing those items in their yard to be mowed over in the spring.

EMERGENCY SNOW ROUTE - Typically when it snows the City employees have two trucks with plows running to clear the streets. The streets cleaned first are **Main**, **South**, and **Third** running east and west. Running north and south are **James**, **Division**, **Lincoln**, **Kennedy** and **Brown** Avenue - north of the highway. By cleaning these streets first, the majority of Alma citizens will have only one or two streets of snow to drive through to get to a cleared street.





Although the water from our City wells is safe to drink and meets all State and Federal standards, there is still a possibility that the water will not maintain the same high quality in the future.

The City Council has adopted a plan to protect our drinking water sources (our city wells) from sources of contamination with a Wellhead Protection Plan. The Wellhead Protection Area is the surface and subsurface surrounding our wells through which contaminants are likely to move toward and reach the wells. The Wellhead Protection Area has been delineated by the Nebraska Department of Environmental Quality. The area is determined by several factors including location, number of wells in the system, amount of water pumped by the wells, and groundwater flow direction. The complete plan is kept at city hall and can be viewed by the public.

The old saying that "an ounce of prevention is worth a pound of cure" is definitely true when it comes to our water.

LICENSE YOUR DOG IN DECEMBER

The City reminds you to license your dog this December by purchasing a 2024 tag. The cost is \$7.25 for a male or spayed female and \$12.50 for an unspayed female. Pursuant to City Code 90.20 to 90.22, any dog over the age of 6 months shall be licensed within 30 days of acquisition and annually by the 1st day of January of each year. Said tax is considered

delinquent after March 10th. To license your dog, stop by the City Office and be sure to bring your certificate proving your dog has had their rabies shot effective for the licensing year.

CODE RED ALERTS—

The CodeRED notification system sends important alerts and timesensitive message to our residents, but you must sign up for it. Residents can choose several different methods of notification—landline, cell phone, email, text, TTY, or a combination of them. DOGS RUNNING AT LARGE

Per City Code 90.26—Any dog found off the premise of the owner, and not under control of the owner or a responsible person, either by leash, cord, chain, wire, rope, cage or other suitable means of physical restraint may be taken up and impounded. If the police cannot reasonably do so, they may kill on sight any dog found to be running at large.

<u>Protect your Dog this Winter</u>

Winter weather will be upon us. Just like we bundle up and take care of ourselves while we are out in the frigid cold, we also need to be thinking about our 4-legged friends.

Keep in mind the temperatures and the weather conditions when your animal is outside. Do not leave your pets outside for extended periods of time during cold or inclement weather conditions. Snow and wintery weather can pose a risks to your dog's which can cause them discomfort. Their sensitive paw pads can get dry, cracked or even frostbitten when they are out in the elements. Also, a buildup of snow and ice can irritate the sensitive skin between their toes.

Not only are the temperatures dangerous but add in the danger of ice melt products which can cause chemical burns to their paw pads or indigestion if your dog tries to lick it off.

Dog booties are an option if you are going to have your dog out for extended periods of time for wintertime play. There are various options for stylish sweaters and outerwear for your pooch as well at your nearest retailer or online to keep them warm.

GAS PIPELINE SAFETY

As one of the thousands of people who live or work near pipelines, you can help keep it safe and reliable by doing the following:

A) notify us with your intention to dig;D) take appropriate steps if you notice a leak;

B) identify our pipelines;E) immediately report a leak

C) recognize a leak;

The City of Alma cares about your safety. Our employees are thoroughly trained to operate and maintain the system safely. We want you to be aware of our pipelines. We ask for your help in preventing accidental damage to pipelines. The City of Alma supports the Nation's Homeland Security efforts and the City of Alma encourages you to immediately notify and report any suspicious persons and/or activities near the pipeline to your local law enforcement authorities by calling 911.

A) NOTIFY US WITH YOUR INTENTION TO DIG - CALL 811-"diggers hotline"

We need your help in preventing pipeline emergencies. The number one cause of pipeline leaks is damage from earth-moving and construction equipment and tools owned by parties other than the pipeline company. If you plan to dig or do any type of excavation or construction work, call **Diggers Hotline at 811**. Call at least 48 hours (excluding weekends and holidays) before you:

Excavate	Install drain tile	Repair or rebuild roads or driveways	
Grade	Blast for clearing	Build homes or additions	
Auger	Dig postholes	Install water lines, sewer lines	
Bore	Cut or deepen ditches	septic systems, or drains	
Tunnel	Install swimming pools	Install telephone, TV or power, cables	
Dredge	Plant trees or shrubs		

B) IDENTIFY OUR PIPELINES -HOW TO IDENTIFY WHERE THE PIPELINE IS LOCATED

Since pipelines are buried underground, line markers are used to indicate the approximate - *not exact* - location of the pipeline. Line markers can be found where the pipeline intersects a street, highway, or railroad. However, they cannot be relied upon to indicate the exact position of the pipeline. The pipeline may not follow a straight course between markers, which provide no information on the depth or number of pipelines in the vicinity. Don't try to guess the pipeline's location or route by the marker's placement. Call Diggers Hotline at **811**.

C) RECOGNIZE A LEAK

HOW TO RECOGNIZE A PIPELINE LEAK WHEN NEAR A PIPELINE RIGHT OF WAY. <u>LOOK FOR</u>: Fire or explosion near pipeline, a white cloud or fog, dying plants amid healthy ones, unusual blowing of dirt or dust, persistent bubbles in water, or pool of liquids, possibly bubbling. <u>LISTEN FOR</u>: Hissing or roaring sound. <u>SMELL FOR</u>: A pungent odor, sometimes like rotten eggs.

Immediately leave the area - on foot - in an upwind direction.	 Warn others to stay away from the area
DO NOT drive into an area in which you encounter a leak or vapor cloud	DO NOT try to operate any pipeline valves yourself

DO NOT light a match, start an engine or automobile, use a telephone, or switch on/off an electric light or appliance.

D) TAKE APPROPRIATE ACTIONS IF YOU NOTICE A LEAK- WHAT TO DO?

E) IMMEDIATELY REPORT A LEAK- WHO TO CALL?

From a distant phone, call the City of Alma (308-928-2242) or the On-Call phone if after hours (308-920-1047) OR call 911 or your local fire, police or sheriff's office. DO NOT use a cell phone while near the suspected emergency area.
